- **1.** Approved minutes of meeting on April 18, 2016.
 - **a.** MOTION to approve the minutes by Will, second by Darala. Vote: 7 approved, 0 opposed, 0 abstained. MOTION APRPOVED.
- 2. Board terms. Will reported that according to the City Council's counsel, the City Council can consider a request to extend the terms for EID board members to three years. The request would be made at the end of 2015, when the 2016 board members will be nominated.
- **3.** Treasurer update: According to the Marion County Treasurer's office, the total EID assessments collected in the Spring tax bill are about \$600 short of projections. Funds should be available by the end of June. The EID board Treasurer will open bank accounts when funds are available.
- **4.** Landmark award: Decided not to apply this year, due to winning the award last year.
- **5.** Insurance update: Jake not in attendance, so no update.
- 6. Policies: Justin will update board at next meeting.
- 7. Budget: A discussion ensued on reallocating Department of Public Works (DPW) and EID funds from the original budgets. A reallocation was necessary because of the different limitations and requirements of each funding source. For example, DPW funds have to be spent in 2016 and generally require three bids.
